- Final arrangements must be made no later than 14 days prior to the event. At this time all menu selections as well as the number of guests will be final. All further changes will be subject to additional charges.
- Payment must be made at the conclusion of the event. We accept Cash, Check, or Credit Card.
- Indiana State Health Regulations require that Crawfordsville Country Club provide all food and beverage items for events.
- State Excise Regulations prohibit alcoholic beverages from being brought onto the property by members & guests.
- ALL GUESTS WISHING TO PURCHASE OR CONSUME ALCOHOLIC BEVERAGES WILL BE REQUIRED TO CARRY AND PROVIDE A VALID PHOTO ID.
- Crawfordsville Country Club reserves the right to limit the consumption of alcohol by members & guests.
- The patron will be responsible for the booking of such services as a DJ, band, wedding cakes, etc. Management must approve any outside contractors.
- The Crawfordsville Country Club is not to be held responsible for any decoration brought in that may be lost, stolen or destroyed. This also includes any item or items that may be left on the property.

Description of Fees

Room Charge

You may request a room to be booked for your function based upon the number of guests attending the event and other events scheduled at that time. If this number fluctuates it may be necessary for the Club to reassign the room for your function. We also insist that notice of any changes in guest count be made at least 10 days in advance so that the Club may make the necessary adjustments for your event. At this time the guest count will become and remain final. Crawfordsville Country Club members are exempt from rental charges.

Clubhouse Charge

This charge is for those receptions wishing to rent the entire Club. This would allow for the bar to be closed to the membership and the whole facility would be exclusive to wedding guests. In order to do this, the minimum number of guests must be 200 and at least 60 days' notice must be given to allow for the membership to be sufficiently notified.

Basic Wedding Reception Package

The Crawfordsville Country Club wedding experience includes:

- Standard room set up including stock linens and skirting
- All plates, silverware, glassware, etc.
- Cake table, gift table, head table, etc.
- Room availability 8 am day of the event

These are covered in the set-up fees. Other options are available for an additional cost. Events over 225 require a completely different type of set up so additional charges will apply.

Tax and Service Fees

20 % Service fees will be added to the event's bill along with the state regulatory sales tax of 7%. Gratuity will be paid out of these fees.
