

## LONE STAR RIVERBOAT CHARTER AGREEMENT

THE LONE STAR RIVERBOAT is available for private charters for groups of 30-100 guests. The charter boat cost is \$19.00 per person (\$17.00 per person 81-100 guests) plus state sales tax @ 8.25% & 15% gratuity for a two-hour period. If more time is desired, there is an additional \$200 per hour charge plus tax and gratuity. The fees include thirty minutes prior to departure for boarding, 45 minutes prior to boarding for decorating, set up, deliveries or band assemblage.

The minimum fare is \$570.00 ( $30p \times $19.00$ ) plus tax and gratuity - with a \$500.00 deposit to be paid in advance. The deposit secures the date, guarantees fulfillment of the agreement, and can be applied towards the final bill. However, if damage or theft occurs during the charter, the deposit will be held until restitution is made by the person who booked the charter. In case of extremely bad weather, as determined by the captain, or problems that may affect boat safety, the deposit will be refunded. Deposit is not refundable if cancellation is made by the host. Deposit will be refunded if cancellations made by Lone Star Riverboat for any other reason.

With the Covid variants a possible concern - we may have to limit the number of guests on our boat and other safety measures set in place by an outbreak - we will refund you if this effects your event. We are taking extra measures for your health and safety and we ask that all hosts do the same for their guests.

Payment for all services is expected at the end of the charter. We request the host use a credit card or check and collect all payment in advance from individuals. Optional food and beverage service are available at an additional cost; it is not included in the charter fee. (If you choose to cater a meal, a 30-person minimum charge is required.) \*Any cancellations less than 24 hours prior to the charter will result in the full catering fee in addition to the \$500.00 deposit. The riverboat's owner accepts no responsibility for accidents caused by passenger negligence. It is expected that the passengers will stay within the confines of the railings and use handrails when ascending or descending the stairs.
