## Terms and Conditions

\_\_ On the noted wedding date, the number of hours offered is meant to begin when the photographer walks into the first venue and ends when they complete breakdown at the last location. All overtime will be billed, and is to be paid at the overtime rate of \$100 per hour.

\_\_ The noted party agrees that full payment of the Package Price must be paid in two installments. The first being a non-refundable security deposit of \$300 is due at the time of signing the wedding contract. Final payment of remaining balance is due on the wedding day. All additional orders for albums, prints, DVDs, etc. and any overtime must be paid in full when placing the order.

\_\_ Upon payment in full to Chris Stutz Custom Photography of all amounts due to Chris Stutz Custom Photography, ownership and possession of the digital images will be given to you. Chris Stutz Custom Photograph will share the copyright of photographs taken on the noted wedding date as samples of its work, for the purposes of window and showroom exhibits, advertising including printed publications, professional competition and world wide web.

\_\_ The noted party agrees Chris Stutz Custom Photography is the exclusive, official photographer retained to photograph the noted wedding date specified on this contract.

\_\_ A travel fee (50 cents per km charge) is charged when roundtrip travel from our office exceeds 100 km. These travel fees are quoted on an individual basis. All such travel fees and other charges will be added to the wedding contract which is due on the event date.

\_\_ The noted party agrees that Chris Stutz Custom Photography shall not be liable for any personal injury, loss or damage to property occasioned by any act or omission of the photographer(s).

\_\_ The noted party acknowledges and agrees that the liability of Chris Stutz Custom Photography, its photographers, no matter howsoever caused, is limited to the following refund policy:

- if Chris Stutz Custom Photography is unable to supply the noted party with any photos from any coverages due to circumstances beyond its immediate, direct and reasonable control, including but without limiting the generality of the foregoing, due to digital film defect, camera or flash or lighting malfunction, then Chris Stutz Custom Photography will give the noted party a refund for the amount paid for the affected coverages.
- if the photographers do not meet the noted party's reasonable expectations, and if the same arise solely and exclusively because the photographers failed to perform their services in a reasonably competent manner under the circumstances given to them, then Chris Stutz Custom Photography will give the noted party a refund for the affected coverages in an amount determined by Chris Stutz Custom Photography, acting reasonably, but in no event to exceed the amount paid for the affected coverages.

\_\_ 100% (one hundred percent) of the payments paid are forfeited if this Wedding Photography Contract is broken, cancelled or terminated prior to and including the noted wedding date.
