2. LCF will begin 45 minutes before ceremony and continue at reception, combined time not to exceed 8 hours unless prior arrangements have been made. Client agrees to cooperate fully with LCF and understands that without full cooperation by the Client, the desired product will not be created. Client satisfaction cannot be guaranteed.
3. It is understood and agreed that LCF cannot guarantee to produce any video product of any specific object(s), situation(s), person(s), or event(s) or any combination thereof.
4. If the total job/event time exceeds four (4) hours, LCF personnel must either be supplied food and non-alcoholic beverage(s) by Client or LCF personnel shall be permitted a time period not to exceed one (1) hour to obtain refreshment.
5. LCF reserves the right to determine the assignment of Videographer(s) for this assignment.
6. It is understood that Mirage Productions is the exclusive official Videographer, and others taking videos/photos will be permitted only at our discretion.
7. To secure a date with LCF, a non-refundable retainer of \$400.00 will be required for all single packages and \$600.00 for all two-camera packages.
8. In the event of a postponement or cancellation of this contract, all non-refundable retainers will be forfeited (\$400.00) or (\$600.00)
9. LCF reserves the right to use the original tape, Video Files and/or reproductions for display, publication or other purposes, without prior permission.
10. LCF takes utmost care with respect to the exposure, editing, duplication and delivery of the video products and services offered. However, in the event LCF fails to comply with the terms of this contract due to any event or act outside of the control of LCF, the liability is limited to the refund of the payments received.
11. Additional original DVD's may be purchased for \$25.00 per DVD. These DVD's will be available for 3 months after delivery of edited master media.
12. Please notify your photographer, that a Videographer will be present.
13. An additional 1/3 of your total contract total is due 60 days (2 months) prior to your event date, your remaining contract balance due 10 days prior to event date. (i.e. Wedding Day)
14. A \$40.00 charge will be added for any returned checks and must be paid before delivery of media.
15. Any delay in payment will result in a \$50.00 or 30% per week late fee, whichever is greater unless prior written arrangements are made.
16. Video(s) will be mailed 4-6 weeks after music and final payment are received.
17. Client will be provided 14 (fourteen) days from the ship date of their rough cut copy to request noticeable changes to your DVD. If no requests are made, your final DVD's will be created and mailed. No change requests will be accepted after the 14 (fourteen) day period.
