*SERVICE CHARGE AND SALES TAX*

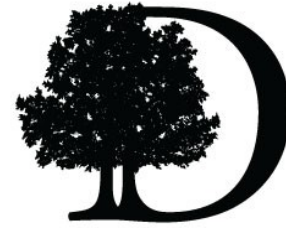
