**BALANCE DUE/DATE:**

**OVERTIME: \$50.00/HALF HR.** When feasible, Client requests for extended playing time during event will be accommodated. Payment is due at time of request, and may be made with check or cash.

**PAYMENT:** Payment may be made with personal/company/cashier's check or cash. Please **MAKE ALL CHECKS PAYABLE TO ABSOLUTE ENTERTAINMENT**. (There will be a \$20.00 fee charged for all returned checks.)

**TO CONFIRM THIS AGREEMENT:** (1) SIGN ONE OF THE TWO AGREEMENTS (must be 18 yrs. or older). RETURN ONE SIGNED COPY TO DJ. Retain the second copy for your records. (2) THE DEPOSIT MUST BE RECEIVED WITH RETURN OF THIS CONTRACT BY THE DUE DATE TO GUARANTEE SERVICES FOR YOUR EVENT.

**CANCELLATION:** This Agreement cannot be cancelled or modified except in writing by either the Client or DJ. If Client initiates cancellation less than 60 days prior to the event, then only the deposit will be forfeited. If Client initiates cancellations less than 30 days prior to the event, then Client is responsible for the total fee OR may forfeit deposit only by signing a new Entertainment Agreement with DJ within 14 days of cancellation for a substitute engagement performed in the following 6 months. Rescheduling for events canceled due to inclement weather shall be accommodated without penalty whenever possible. Rescheduled event are subject to availability.

**PROVISIONS:** The Client shall ensure that: (1) performance facility provides DJ with a sturdy covered table approximately 2x8 feet in an area within 25 feet of performance area; (2) the table shall be within 25 feet of a reliable 15-ampere circuit (3-prong grounded) for audio and/or a reliable 20-ampere circuit (3-prong grounded) for lighting effects; (3) facility is open at least one hour prior to schedule start time; (4) facility meets all federal and state safety regulations and has all appropriate music licenses and performance permits where applicable; (5) reasonable steps will be taken to protect Absolute Entertainment's equipment, personnel and music, and crowd control will be provided if warranted; (6) for outdoor performances, shelter is provided that completely covers and protects Absolute Entertainment's equipment from adverse weather conditions.

Client accepts full responsibility and is liable for any damages, injuries, or delays that occur as a result of failure to comply with these provisions. In the event of circumstances deemed by DJ to present a real or implied threat of injury or harm to DJ, equipment, or recordings, then DJ reserves the right to cease performance until such time as Client resolves the threatening situation. DJ further reserves the right to deny any guest access to recordings or equipment. In the unlikely event the DJ's performance is delayed, liability is limited to providing Client with performance time equal to time lacking. DJ holds all appropriate insurances for its equipment and personnel.

**PLEASE SIGN BELOW AND RETURN YOUR SIGNED COPY ALONG WITH THE DEPOSIT AMOUNT NOTED ABOVE.** This Entertainment Agreement supercedes all others for the aforementioned event date and is subject to the laws of the State of Oregon.
