All private parties require a valid credit card number, which will only be charged if you are in violation of the terms listed below.

The minimum number of painters is 10. There is a non-refundable travel and set up fee of \$125.00 due upon reservation and a \$75.00 reservation fee which will be credited towards the event or refunded once the terms of the agreement have been met. As the host of the private party, it is your responsibility to make sure that you have the minimum number attending. We suggest that you collect the appropriate payments from your group in advance, or we can post your event on our online calendar where your guests can reserve their seats with their credit card. You will be charged for the minimum amount of the class if the attendance does not reach the 10 painters on the day of the event. In the event you need to cancel or reschedule your party, a minimum of one week (7 days) notice is required.
