

Officiant Winsome's Terms & Conditions

1. A non-refundable down payment of 50% of the total cost of the wedding is required to secure the date and time.
2. Payment of the balance is due seven (7) days before the wedding ceremony. Couple understands that the forms of payment accepted are Cash, Credit/Debit Card via PayPal (paypal.me/thewinsomepaperie), or Money Order made out to Winsome Battle. Personal checks are not accepted.
3. Couple agrees that they understand what package they are entering into and that they have read the details as to what is included in their package. If they have any questions to this, they have discussed this with the officiant.
4. Any admission or parking fees associated with the wedding venue are to be paid for by Couple.
5. Couple understands that there may be a travel fee for weddings outside 20 miles outside of zip code 35805.
6. Officiant agrees to assist the couple in a consultation. Likewise, the couple agrees to provide information and be involved with the planning of the ceremony. Couple understands that ceremony details are at their discretion, according to their wishes and needs. Couple may piece together a ceremony of their liking, using samples, write their own ceremony completely, or write just their vows. Officiant retains the right to edit the ceremony to meet applicable laws or local regulations. The Couple agrees to have chosen wording to the Minister no later than one week prior to the service.
7. Officiant agrees to perform the ceremony in a respectful and professional manner in accordance with the ceremony planned by the couple. Couple agrees to acknowledge the services being provided by the Officiant, in a dignified and respectful manner, and if there is any discrepancy or concern regarding services received, Couple must contact A Winsome Marriage immediately. Couple agrees to not post negative reviews on the Internet (or elsewhere) or to make negative verbal or written statements until all efforts to resolve said discrepancy have been exhausted.
8. This contract will guarantee Officiant's availability for the Couples' wedding date and time, as well as the rehearsal (if purchased with package), thus preventing the Officiant from booking another wedding at the same date and time. If there is a change in the specified date and/or time of the wedding or rehearsal, Officiant must be notified immediately.
9. In the event that A Winsome Marriage is unable to attend and perform the services as planned due to hospitalization, auto accident, transportation breakdown/disruption, traffic difficulties or other unforeseen incapacitation on the day of the ceremony, A Winsome Marriage will send an alternate who will provide the same level of service, if we are unable to provide an alternate we will provide a 100% refund.
10. If a decision is made not to use the services of the Officiant after retaining of services by deposit, the Couple must inform the Officiant, in writing, at least thirty (30) days prior to the wedding date in order to release the Couple from this contract. Couple understands that in the event of a cancellation, the down payment of 50% is forfeited. Failure to provide such notice, or cancellation, will result in Couple being responsible for the remainder of the balance per package choice listed above.
11. This contract, once signed, is considered by all parties within to be legal and binding in accordance with the conditions set forth herein, and all shall abide by the agreed upon terms.
