

We are delighted that you are interested in holding your special event at the Red Fish Grill. Our location is unlike any other in South Florida. The romantic beachfront setting of Red Fish Grill, located in Matheson Hammock Park, provides a secluded spot, with an unparalleled view, to hold any special event.

### **Facilities Rental**

- The rental of Red Fish Grill facilities will include all tables, chairs, white linens, chinaware, silverware, and glassware. If the client wishes to use anything other than the specific items provided by Red Fish Grill, the client can rent any outside items and will incur the charges of such rentals.
- Rental of the Red Fish Grill facilities for an event does not include any supplies or services other than those specifically included in these guidelines.
- Our facilities will hold a maximum of 140 guests per event. In the event of noncooperative weather, we provide a contingency plan for up to 140 guests. Please note, once booked, weddings are confirmed rain or shine.
- Weddings will have a contracted time span of five hours. This time frame is not including the ceremony. The time frame of evening events is between 5:00 p.m. and 1:00 a.m. All events must conclude by 1:00 a.m.
- Guests pertaining to the event are not permitted inside the venue until the start of the contracted five-hour time span. The only patrons permitted inside before the event begins, are vendors and those who are setting up.

- There is no extra charge to hold the ceremony at Red Fish Grill. If the client chooses to hold the ceremony on the beach, the set up cannot begin before 5:00pm. The only rentals permitted on the beach are chairs, an arch, and a linen runner for the walkway. The use of open flames is prohibited. All delivery trucks with rental equipment must park in the parking lot and are not permitted to drive on the beach property. All rental equipment must be carried to the ceremony location. Rented items must be removed from the property immediately following the ceremony by the vendor. Red Fish Grill is not responsible for providing an alternate ceremony location if weather is inclement.
- Red Fish Grill will provide an unlimited, selected bar during the contracted hours of the event. This will include a variety of, red and white wines, sparkling wine, beer, and soft drinks. Please see attached wine list with the selections highlighted. If the client wishes to offer additional wines or a different selection, the price will reflect an increase accordingly. A toast can be provided at no extra charge, if desired by the client.
- \*\*Red Fish Grill does not provide any liquor\*\* If the client wishes to supply liquor for the event, they can do such prior to the start of the event. In the event that the client does wish to supply liquor, Red Fish Grill will provide a portable bar, bartenders and mixers limited to, Pepsi, diet Pepsi, Sprite, tonic water, club soda, orange juice, and cranberry juice.
- Red Fish Grill will provide all contracted food and service for the reception. The
  tentative schedule for the event will consist of a first course of passed hors d'oeuvres
  to be served within the first contracted hour. Once the bride and groom are
  introduced and a number of dances occur, we will provide champagne to your guests
  for a toast. The toast takes place prior to being seated for dinner. The second hour of
  the reception will consist of a sit-down dinner. Salad is served for the second course
  followed by a choice from our prix-fixed menu. We do not require entrée's to be preselected; guests can make their selection once seated when orders are taken. All
  beverages will be served throughout the contracted time.
- Once the **plated** dinner has concluded, the wedding cake portion of the reception will take place. Red Fish Grill does not provide dessert as per the wedding agreement, therefore the client must order the wedding cake and provide for delivery prior to the start of the event. Red Fish Grill will cut and serve the cake, which will be accompanied by coffee and tea service.

## **Events Pricing**

The pricing for weddings/private events to be held at Red Fish Grill is based upon our high and low seasons. The high season begins on November 1st and concludes on May 31st. The low season begins on June 1st and concludes on October 31st. The pricing listed below is for events held on Friday, Saturday, and Sunday nights only. Pricing for events held Monday through Thursday would be lower in cost and calculated on an individual basis. All prices are subject to change.

### Pricing listed below is for any number of guests up to our maximum of 140.

### High Season (November – May)

Friday Night: \$15,500.00 + 8% sales tax + 21% service charge

Saturday Night: \$17,000.00 + 8% sales tax + 21% service charge

Sunday Night: \$14,000.00 + 8% sales tax + 21% service charge

### Low Season (June –October)

Friday Night: \$14,500.00 + 8% sales tax + 21% service charge

Saturday Night: \$16,000.00 + 8% sales tax + 21% service charge

Sunday Night: \$12,000.00 + 8% sales tax + 21% service charge

### **Overtime Fees**

Events are contracted to last five hours. In the event that the client chooses to the contracted time of five hours, a charge of \$500.00 per half hour over the allotted time will be charged to the client. The overtime cannot exceed two hours past the contracted time, or past 1:00 am, whichever is first. A decision regarding a time extension must be made 3 days prior to the event.





### Special Menu Requests

Vegan and vegetarian options are available. Advanced notice is required. We can also accommodate guests who require a gluten free entree.

### Children's Menu

Children are considered part of the 140 guest count. We can offer a cheeseburger and malanga fries.

### Vendor Meals

Entreé selection of fish or chicken. \$35.00 per vendor meal plus tax & service charges. Vendors receive meals once all guests have been served.

### Tastings

All of our menu item's are cooked to order. Guests make their entree selection once seated for dinner. We do not provide tastings. All of our prix-fixed menu entree's and our salad are available on our al la carte menu. We suggest you make a reservation for dinner prior to booking your event.

### Final Guest Guarantee

We require a final guest count at least 14 days prior to your event.

### Parking Arrangements

Parking is plentiful and provided at no charge.

### How to secure your date

A \$5,000.00 deposit is due along with a signed proposal in order to secure your specific date of interest. Final balance is due at least 14 days prior to the event in the form of a certified check.

# Ceremony & Wedding Reception Guidelines Please read carefully

- Matheson Hammock Park does not permit the use of the following objects on their beach property: alcohol, glassware, birdseed, confetti, open flames, Chinese lanterns, or wires running from the Red Fish Grill property.
- All equipment must be carried onto the beach. Vehicles are not permitted to drive onto the premises.
- Any microphones, lighting, or instruments must be battery operated.
- All items must be removed from the beach immediately following the ceremony.
- Smoking is permitted only on our terrace, not inside the building.
- In the event of inclement weather, Red Fish Grill does not provide a contingency plan for your ceremony. We recommend putting a tent on hold. For more information regarding set up time, vendors, and the size, please contact **Brandy** directly.
- Any items related to the wedding must be dropped off and picked up the same day as the event. We are not responsible for items left behind.
- Red Fish Grill does not provide a day of coordinator. It is your responsibility to hire a wedding planner or dedicate someone to ensure the additional décor not provided by the restaurant, is set up accordingly.
- The following items are prohibited in decorating and may NOT be used on the property: -nails -screws -tacks -staples -tape -glitter -confetti -birdseed -sparklers
