| Barn Rental | $\$ 4900$ (5 hour reception) Latest last call 11pm <br> **See page 2 for additional pricing. <br> - The Lessee may have access to The Barn the day prior to the event at 9am. <br> - The balance must be paid in full one week prior in order to have access to the barn. <br> - A Walhill employee is the last to leave the Barn on the night of the event, all individuals must be gone from the Barn within 30 minutes of the event ending - unless otherwise agreed upon. <br> - For additional event time there will be a charge of $\$ 350$ per hour extra. <br> - Personal items must be removed from The Barn by noon on the day after the event. <br> - Walhill will set up all tables, clean and tear down after the event. <br> - The Barn is a non-smoking facility but smoking areas and ashtrays are provided outside under cover. <br> - Barn Rental includes the following decorations \& linens: Globe Lights <br> Burlap Canopy <br> Barn Door Drapes <br> Iron Chandeliers <br> Tablecloths for all tables, includes buffet tables. <br> Added décor and embellishments are available upon consultant at an additional expense. <br> - Endless Fountain Soda included with rental. <br> - Chips \& Pretzels included all night for free at your event. |

No Exceptions. | Bartenders | By law, all alcohol must be served by Walhill's licensed bartenders through Walhill's Liquor License. <br> - Two bartenders are included with the purchase of alcohol. <br> - Each additional bartender is charged at $\$ 15$ per hour per bartender. <br> On average, 1 bartender is required for up to 75 guests with a full open bar or 1 bartender per 125 guests for beer and wine with cash bar. <br> We will work with you to determine the proper staffing for your specific needs. |
| Gratuity | $18 \%$ gratuity will be added on all alcohol and catering. Gratuity will not be refunded on any returned alcohol, this is a service fee. |


| Tables \& Chairs | Barn rental includes the following tables \& chairs. Chairs 450, 34-8 foot tables, 30-6 foot tables, $40 \times 5 \mathrm{ft}$ round tables and $3-4$ foot round tables. <br> This is subject to change. <br> Walhill will set up all tables and linens. Table décor not included. <br> - A consultation with a design professional is included in your contract. They will work with your requirements and develop a floor plan specific for your event. Should you decline this service, you will need to submit a floor plan for approval 30 days prior to your event. |

| Decorating | No nails, staples or screws may be used to hang anything from the walls, rafters and/or ceiling. Candles must be covered by a glass globe or in a glass container. The container must have a bottom to it. No open flames permitted. <br> All non-biodegradable items such as rice, artificial confetti, artificial petals etc, are NOT permitted to be thrown at any event on Walhill property. No hay/straw bales are permitted in the barn. |
| Catering | All catering must be done through Walhill Farm's catering department. <br> Items are selected from a catering menu at catering prices. All meals in The Barn are served buffet style. Items catered by Walhill will include disposable plate-ware, flatware \& napkins. Use of real dinner ware may be rented in through an outside source but bussers will be required. You can provide your own bussers or hire them through Walhill Farm at $\$ 20.00$ per busser per hour. <br> For items not catered by Walhill Farm ie: Cakes. There will be a $\$ 0.40$ per person charge for plate-ware, flatware \& napkins. Alternatively you may bring your own. <br> - Walhill will provide a basic buffet table set up which includes linens. <br> - Your menu needs to be selected 30 days prior to the event. <br> - The confirmed headcount is due 15 days before the event. This final count will be used to calculate the final catering bill, adjustments cannot be made during the 2 weeks leading up to the event. <br> - Cake cutting service is offered for an additional $\$ 100$ fee. Speak with the event coordinator prior to the event if this service is needed. <br> - Chips \& Pretzels are included with your event. <br> In order for catering leftovers to be taken home, you must sign the addendum and provide your own leftover containers. Walhill Staff will package any leftovers to be taken home. |

A Barn Rental deposit of $\mathbf{2 5 \%}$ is due upon receipt of contract. The balance is due one week prior to the event. The deposit is refundable, minus a $\$ 200$ administration fee, only if the reserved date is filled by another event.

A $\$ 500$ refundable security deposit is due the same day as your deposit, and refunded within 10 days following the event, provided there have been no violations of service laws and policies and belongings have been removed from the venue and there is no damage.

## Cancelation Policy

If the Lessee should wish to cancel their Barn rental, they must submit a written cancelation notice. The Lessor, Walhill Farm, will refund the $\$ 500$ security deposit to the Lessee within 10 days of receiving the written cancelation notice. If the canceled date is booked by another event, the $25 \%$ deposit will be refunded, minus a $\$ 200$ administration fee.
If the canceled date goes un-booked, the Lessee does NOT receive a refund for the $25 \%$ deposit made on The Barn rental.
