# How can I book your services?

## 1. Check Availability

Complete the Contact Form on our website at [www.1stweddingvideo.com](http://www.1stweddingvideo.com) or contact us (Page 14) and we will get back to you within 24 hours.

## 2. Provisionally Reserve Your Date in Needed

If your date is available, you can provisionally reserve your date for 7 days without obligation. This gives you more time to view our packages and contact us to discuss your requirements.

No other couples can book your date during this reservation period.

Please note: Your booking is not confirmed until receipt of deposit and completion of your Booking Form.

## 3. Deposit Payment

If your date is available a \$375.00 non-refundable deposit secures your wedding date. Payment by Internet Bank Transfer is our preferred method and we will forward you our bank details upon confirmation of availability.

## 4. Complete our Online Booking Form

Upon receipt of your deposit we will forward you a PDF version of your receipt for your records and a link to our Online Booking Form (no paperwork required). When you have submitted your Booking Form we will forward full confirmation for approval, and that's it. You are all booked in.

## 5. Payment Terms

25% of your final balance is due for payment six months before your wedding date, with the remaining balance due four weeks before your wedding.

Full payment amounts and dates are detailed in your Confirmation Document.

## 6. Price Guarantee (No Increases)

Once your booking has been confirmed your package prices are guaranteed, and any future increases will not apply to your account.

The price you book at is the price you pay!

## Terms and Conditions of Booking (Revised 6-23-)

IST Wedding Video Productions will produce and store a master tape of your finished version on various formats for further copies for you in the future or damage to your own DVD copy. 1<sup>ST</sup> Wedding Video Productions are not accountable for any damage to any master copies, and store them as a courtesy; we would like to note that we do not charge for master tape stock.

Although by paying a deposit and filling out a booking form, 1<sup>ST</sup> Wedding Video Productions are not accountable for any unforeseen problems that may occur on the way to the venues or during video filming, (Inc bad weather/ traffic problems, poor lighting conditions etc.) We regularly check all equipment and, if possible, carry spare equipment, but we shall not whatsoever, be liable for any unforeseen losses, omissions or problems, that occur during filming or in post production and will only be liable for, at the owners discretion, to reducing the original cost or a refund in extreme circumstances. Any refund shall not exceed the total value of the booking. All filming subject to local conditions.

Master (where applicable) are stored at Azure IX Media Inc. and remain the property/copyright of 1<sup>ST</sup> Wedding Video Productions

When booking, a non refundable deposit of a \$375.00 of your total cost is required to secure your booking.

You have the right to cancel your contract within fourteen days from the date of paying your deposit by email or in writing to 1<sup>ST</sup> Wedding Video Productions 684 S Barrington Rd #125, Streamwood, IL 60107.

If you cancel your contract for the services during the Cancellation Period, we shall reimburse you for all payments received from you.

All reimbursements shall be made to you within 14 days and using the same means of payment as you used for the initial transactions, unless you have expressly agreed otherwise.

After fourteen days, the deposit is non refundable as we hold your wedding date and refuse any other clients booking that date. A payment of 25% of your final balance is due six months prior to your wedding date, with the final payment of your balance due four weeks before your wedding. All payments are non-refundable and non-transferable.

The final balance must be settled in full before any filming can commence.

## Make Payments to: Azure IX Media

Any client canceling within three months before the wedding date will have to pay 25% of the balance due. Cancellations less than two months before the wedding date will result in payment of your balance in full. Change of date is classed as a cancellation and therefore cancellation rules apply.

Copies will be made available after production. It is against the law to copy or use any of 1<sup>ST</sup> Wedding Video Productions yourself. It is for your benefit for you to use us for copies, as we have a high quality master to take a copy from, retaining optimum superior quality.

No '1ST Wedding Video Productions' production may be broadcast or uploaded onto television, Internet, in a public place etc or edited in any way without prior permission.

Any differing aspects to the day should be submitted in writing minimum 2 weeks before the day so we can prepare. If in doubt please contact us to discuss. If we do not receive this in writing we cannot be accountable for its omission.

Any requests regarding the editing of your film must be received and agreed in writing before editing commences. If we do not receive/ agree this before the start of your edit we cannot be accountable for its omission. Any changes required after editing may incur a charge.

By booking 1<sup>ST</sup> Wedding Video Productions, we assume you have cleared with the church/ venue all filming rights, and signed and in some cases, paid for the privilege of having the ceremony filmed at the church/venue and establish our filming position with the venue. It is also essential that you ascertain from the vicar/ priest/ registrar etc the positioning for filming the service; please let us know two weeks in advance.

Any additional charges / out of pocket expenses whatsoever e.g. car parking, toll road charges etc are in addition to the stated package prices. Please ensure one car park space is available at all venues we are attending.

The music to accompany your production is your choice and therefore is up to you to seek copyright approval for use within your video to the PRS. We cannot be held responsible for any claims arising from breach of copyright. We can arrange the purchase of copyright licenses, the cost of any license is in addition to any fee paid to 1st Wedding Video Productions. Any copyright license fees must be paid with the final balance of payment no later than four weeks prior to your wedding Date. All music must be provided by you unless by prior arrangement.

Normal post production time is twelve to twenty five working weeks from your wedding date. This is an estimate and 1ST Wedding Video Productions will notify you of any change. This time scale does not include any closure period (holidays etc.) Also this is dependent on confirmation of all details and any music/ photographs etc confirmed and supplied on Memory stick/ Internet upload where required.

DVD – Due to some minor compatibility problems relating to DVD transfer, 1<sup>ST</sup> Wedding Video Productions cannot be held responsible for DVD Authored Weddings that do not play on your home DVD Player.

1ST Wedding Video Productions may at our discretion use any footage, names, dates etc taken from your film for promotional activities. This may include, (but not be limited to), inclusion on our website, promotional materials etc. If you wish not to be included in this then please contact us in writing.

Creative Brief - Unless otherwise agreed, the Customer accepts the Company's decisions on creativity within the product(s) or service(s).

Any queries must be received in writing within 48 hours of delivery of finished product. 1<sup>ST</sup> Wedding Video Productions cannot be held responsible for removal and disposal of raw footage after this time.

The Price Lists and Packages quoted are for all wedding services starting 12:00 noon or later. If your wedding service begins earlier than this then a small extra charge or a reduction in final filming time may be applicable. Please contact us to discuss. Filming starts approx. 60 minutes before wedding service (depending on package).

These terms and conditions of business and the contract between parties shall be construed and applied in accordance with the Law of England and shall be subject only to the jurisdiction of the English courts.
