Payment Terms: A \$60.00 non-refundable deposit upon booking is required to secure room reservation. Deposit will be accepted via credit card which will be kept on file to be charged in the case of incidental charges including but not limited to time overages or damages to facility and/or equipment. Remaining balance will be due in full immediately following rental period. Alternate forms of payment will be considered on a case by case basis.

Liability: PERFORMANCE PLUS/RVP STUDIOS is not responsible for any injuries or lost/stolen property for the duration of the rental period. RENTER agrees to exercise all due care in keeping, caring for, and preserving the facility. RENTER is responsible for all losses or damages to facility and all equipment/furnishings.

Fireworks, Open Flames or Fog/Smoke machines are **not to be used** in the dance room.

Termination: PERFORMANCE PLUS/RVP STUDIOS reserves the right to terminate this agreement at any time. RENTER must comply with termination and will remain obligated to pay any remaining balance and costs accrued through rental period.

Cancellation of this event by the renter requires 48 hours notice. If 48 hours notice of cancellation is not provided, the full balance due of this event contract will be charged to the renter. (Initial: \_\_\_\_\_)
