

# WEDDING OFFICIANT CONTRACT

This Agreement made between Passionate Edge LLC \_\_\_\_\_ (BRIDE) and \_\_\_\_\_ (GROOM) (known in this contract as "Couple") is for the purpose of retaining an officiant to perform a marriage and wedding ceremony on the Couple's behalf.

\_\_\_ Passionate Edge LLC agrees to be available in assistance with the couple in providing support and guidance during the planning stages of the wedding ceremony and through the final vows of the wedding ceremony itself.

\_\_\_ Passionate Edge LLC agrees to perform the ceremony in a respectful and professional manner in accordance with the ceremony planned by the couple. Passionate Edge LLC will dress appropriately for the wedding and arrive early on the day of the ceremony. In the unlikely event that the Passionate Edge LLC is unable to perform the ceremony for unforeseen circumstances (ie. death, accident, injury, etc.) Passionate Edge will do his best to find a replacements and return all monies paid to him back to the Couple.

\_\_\_ Passionate Edge LLC agrees to sign the wedding license after the ceremony and to mail it back to the county within 9 days after the wedding, unless the Couple is already married and does not need a license signed

\_\_\_ At least one day prior to the wedding (unless other agreements have been made) the Couple agrees to pay:

\_\_\_ This contract will guarantee Passionate Edge LLC availability for the Couples' wedding date and time; thus preventing Passionate Edge LLC from booking another wedding at the same date and time. If for any reason, a decision is made not to use the services of the Passionate Edge LLC, the couple must inform the Passionate Edge LLC in writing (email or letter) 7 days prior to the wedding date in order to release the Couple from this contract. If the Couple fails to provide such notice, the Couple agrees to be responsible for the remainder of the balance owed the Passionate Edge LLC

\_\_\_ The Couple and Passionate Edge LLC agree to act in good faith towards one another and to communicate openly and honestly during the length of this contract

IN WITNESS WHEREOF, the parties hereto agree to the terms and conditions as described above and have caused this Contract to be signed on the dates indicated below. This contract, once signed, is considered by all parties within to be legal and binding in accordance with the conditions set forth herein, and shall abide by the agreed upon terms. The parties agree that the specifics of the agreed ceremony shall be considered a part of this contract after signing
