

It is understood and agreed upon by the parties hereto that the Kawartha Golf & Country Club (1983) shall not be liable or responsible in any manner whatsoever for any damages sustained by any party to the Contract or by any other person, firm or corporation and the Convener agrees and undertakes to indemnify Kawartha Golf & Country Club, and it's officers, against any and all claims and expenses presented by any person, firm or corporation for any damages resulting from:

- K.G.G.C being unable to perform the services set out in the contract as a result of any strike, flood, fire, hydro failure, force majeure or Act of God.
- The conduct of any person or persons attending the function.
- The conduct of the Convener or the management of the function by the Convener.

2. The Convener agrees to indemnify and save harmless Kawartha Golf & Country Club and it's officer's, against any and all Claims and expenses presented by any person or persons, firm or firms, corporation or corporations, attending the function for loss or damages sustained in the areas of the Kawartha Golf & Country Club designed for the holding of the function.

3. A minimum guaranteed number of guests for meals must be given no less than 7 days prior to the function. The confirmation of the minimum guest attendance will be used for billing purposes, providing that the number in attendance is not greater than confirmed.

4. Kawartha Golf & Country Club is a Smoke-Free Environment in accordance with the City of Peterborough by-laws and all guests must abide by the Club's "Code of Conduct".

5. Five Hundred (\$500.00) dollar **NON-REFUNDABLE** deposit is required, unless otherwise stated in covering letter.
