Services + Amenities

Each package includes the following amenities:

- Private "Bridal Ready Room" on property at A Taste of Alaska Lodge
- Bartender(s) + parking attendant(s) + additional staff, as necessary
- Access to covered outdoor ceremony space + patio furniture
- Table, chair, and general indoor arrangement set prior to client arrival
- Indoor metal (black only) chairs + stools up to selected guest amount*
- Outdoor chairs (white only) up to selected guest amount*
- Cocktail, round, or banquet tables + black or white linens up to selected guest amount*
- Access to (2) 65" LED TVs for airplay or direct line use
- Access to indoor/outdoor (9) speaker Sonos sound system
- Access to portable microphone + speaker system

** Limited to inventory on-hand. Additional chairs, tables, and linens may be obtained for an additional charge.*

Additional Services + Amenities

- **Event Clean-Up Service** | \$195 to \$345 (variation based on guest occupancy and decor)
 - Includes: safely packing decor and other event items for easy pick-up within 24 hours, overnight refrigerated storage of supplies/decor (when possible), dishwashing, trash removal, rearranging of furniture to standard set-up, and floor sweeping/cleaning
 - *NOTE - If a client chooses to clean/pack items on their own, this is done so as part of the rental time. Additional time, overnight items, trash, etc. will not be allotted.***
- **Tea and coffee Service** | \$55 to \$75 (variable, based on guest count)
 - Includes unlimited, brewed coffee from North Pole Coffee Roasting Co., various teas, and all accoutrement (i.e. mugs, sugar, creamer, etc.)
- **Beverages**
 - Alcoholic beverages allowed onsite, but must be served by our staff
 - Guests may purchase their own beverages from the vendor(s) of their own choosing
 - **ALLOWED BEVERAGE TYPES:** Beer, wine, seltzer, cider, and champagne may be brought in at client's own cost for no additional fee
 - **Liquor** (e.g. vodka, tequila, gin, whisky, etc.) is **only allowed with the use of another company's liquor license**. We recommend hiring Goldie's Bar to meet this service need.
 - Liquor may not be brought on property for personal consumption. No exceptions.
 - If a guest or client is found consuming or in possession of liquor/spirits, **staff will confiscate and charge the client a non-negotiable fee of \$250 per confiscation.**



The Fine Print

Aurora Pointe Staff

Aurora Pointe Staff services are required for all events. No guest or client will ever be allowed on the property without specific invitation or confirmed reservation.

Staff may refuse service to any guest or client who is disorderly or behaving in a manner that is unsafe for themselves or others, or in a way that goes against the property rules and expectations. Staff will ask guests to leave the property if they are unable to adhere to guidelines or directions.

Booking Deposit, Cancellation, and Rescheduling Policies

Aurora Pointe requires a non-refundable deposit which is applied toward the overall balance of the estimate. Deposits are completely non-refundable under any circumstance. The deposit due for all packages is \$1,000.00. This fee is required to secure a reservation. It is non-refundable as this payment guarantees the date and time agreed upon, and ensures that no other reservations for said date and time are accepted.

The remaining balance of the estimate is due 60 days before the event date. Late payments may be subject to a \$50.00 penalty per week past due. At the time of reservation, a detailed estimate quoting the estimated costs of services will be provided, which will also include a suggested payment schedule. All payments are completely non-refundable if the event is cancelled or rescheduled within 180 days (6 months) of the reservation date. An event may be rescheduled once at no penalty or additional cost to the client, if done so outside of 180 days (6 months) - any additional rescheduling will forfeit the original deposit and other payments received. A new deposit will be required to secure any new date.

Damage Holding Deposit and Prohibited Items

Aurora Pointe has the right to hold a major credit card on file for \$300.00 for potential damages. The client will be held responsible up to the full amount for damages they or their guests accrue while utilizing the center's facility even if costs occur beyond the \$300 deposit. The full Damage Holding Deposit will be reimbursed within seven days after the event if no damage is done to the facility during the event. Refunds may take up to 30 days to reflect on credit or bank accounts.

Potential damages may include, but are not limited to: Cleaning/removal of bodily fluids (e.g. vomit, blood, etc.), damage to concrete floors, windows, doors, fields, walkways, adjacent buildings, furniture, equipment, or other items owned and controlled by Aurora Pointe. Damages or excessive cleaning beyond ordinary wear and use may also include the removal of pet hair or pet-related messes, or items from caterers or other guests/businesses for the event.

Prohibited items may include, but are not limited to: Open-flame candles, glitter, fireworks, liquor, flasks, pets, firearms/weapons, and any other item that causes potential risk for personal injury or property damage.
