- 1. <u>Equipment.</u> The harpist will provide the harp, music stand, and chair. The client MUST provide sufficient lighting. Additionally, if the event is to be held outside, the client must provide solid, flat ground or a platform for the harp and harpist to perform on. The client is in charge of providing a microphone or speaker as desired.
- 2. <u>Venue and Weather.</u> The harpist agrees to provide services at the agreed upon venue and location: XXXXXXXX. In the event of a venue or location change, this contract may be voided subject to the harpist's discretion. The harpist will not play outdoors in inclement weather or direct sunlight (at the discretion of the harpist). In case of a necessary venue change, (including inclement weather), the harpist may play at an alternative location if a backup plan has been discussed and agreed upon prior to the day of the event.
- 3. <u>Special Requests.</u> All special requests must be submitted four weeks prior to the event. All other selections are left to the harpist's best judgement and discretion.
- 4. <u>Pricing.</u> Payment is due on the day of the event: XXXXXX. Payment will only be accepted in forms of cash or through the app "venmo." NO CHECKS WILL BE ACCEPTED.
- 5. Overtime performance. The fee for additional playing will be 50.00 per half hour or portion thereof by mutual agreement of the agent and client.
- 6. <u>Emergency and Illness.</u> In extreme case of emergency or illness which renders the agent unable to attend to perform, this agreement will become void. The agent named above will use best efforts to arrange a substitute.
- 7. <u>Break Times.</u> The harpist will be allowed to take 5-7 minute breaks at the top of each hour then will promptly continue playing at the conclusion of the break.
- 8. <u>Cancellation.</u> Client will be responsible for 100% of the payment if event is cancelled later than 30 calendar days before the service is provided.
- 9. <u>Rehearsal Dinners and Wedding Rehearsals.</u> The harpist will not attend weddings/ rehearsal dinners unless agreed upon prior signing the contract. The client will be subject to additional fees for extra mandatory rehearsals.
- 10. Client should sign both copies; retain one for your records and return one to the agent at the address listed for the agent above. The contract will become void if the agent does not receive it within 14 calendar days of the agent's signature below.
