## EVENT TERMS & CONDITIONS

Agreement and Deposit: A signed Event Agreement and deposit are required to secure the date and time of your event. The deposit shall be applied to the final bill, which is due the day of the event.

Cancellations: Any event cancelled prior to 10 days of the event shall receive a 50% refund of the deposit. All deposits are non-refundable for cancellations that occur 10 days or sooner from the event date.

Guaranteed Guest Count: Yeoman's will charge the per person food charge for the guaranteed number of guests or total number served, whichever is greater. Event Organizer shall have the right to modify the guaranteed guest count no later than 5 days from the event date by contacting a manager on duty.

Food and Beverage: All food and beverage shall be served by Yeoman's.

The only exception is a celebratory cake from a licensed bakery.

No other carry in items shall be permitted.

<u>Tax and Gratuity:</u> 7.5% sales tax shall be added to the entire bill, including facility & Activity fee. 20% service charge shall be added to the food and beverage portion of the bill, plus any additional fee charged to meet the minimum food and beverage requirement.

<u>Food and Beverage Pricing:</u> All alcohol and bar items shall be charged at regular pricing based on actual consumption. Food is charged per person, based on the number of food items selected, and soft drinks including fountain sodas, coffee and tea are included in the price. Price per number of items ordered is as follows

Items - \$25 per person Items - \$30 per person Items - \$35 per person

Quality Standards: In keeping with the commitment to responsible alcohol service, Yeoman's reserves the right to refuse alcohol service to any individual attendee or a group at any time. Yeoman's may choose to request proper identification prior to serving any alcoholic beverages to any person requesting such service.

<u>Decorations</u>: Decorations must be approved by Yeoman's management. Confetti/Glitter is not permitted. The guest is responsible for taking down all approved decorations before leaving, and in the event there are any damages caused by the decorations, the guest is responsible for the repair costs if any.
