FREQUENTLY ASKED QUESTIONS

IS THERE A MINIMUM EVENT DURATION?

YES, AN EVENT MUST BE A MINIMUM OF 3 HOURS. ADDITIONAL FOOD & DRINK FEES MAY APPLY FOR EVENTS LONGER THAN 3 HOURS.

IS A FOOD & DRINK PACKAGE REQUIRED? CAN WE BRING OUTSIDE FOOD?

YES, A FOOD & DRINK PACKAGE IS REQUIRED TO HOST AN EVENT. WE DO NOT PERMIT OUTSIDE CATERING.

HOW LONG IS THE FOOD REPLENISHED? AND DRINKS?

FOOD IS REPLENISHED FOR THE FIRST TWO HOURS OF AN EVENT. OPEN BAR IS AVAILABLE FOR THE STANDARD EVENT TIME OF 3 HOURS.

ARE GUESTS UNDER 21 ALLOWED?

IF YOUR EVENT IS BOOKED DURING A TIME OUTSIDE OF OUR NORMAL HOURS OF OPERATIONS, GUESTS UNDER 21 ARE ALLOWED. OTHERWISE, GUESTS UNDER 21 ARE NOT PERMITTED UNLESS OTHERWISE AGREED UPON BEFORE THE EVENT IS BOOKED.

IS THERE PARKING?

ALL GUESTS ARE EXPECTED TO UTILIZE STREET PARKING BY DEFAULT. ACCOMODATIONS CAN ALSO BE MADE IN ADVANCE TO RENT A NEARBY PARKING LOT WHICH WE RECOMMEND FOR LARGE PARTIES. PLEASE REACH OUT TO OUR EVENTS COORDINATOR TO LEARN MORE.

HOW DOES GRATUITY & TAX WORK?

A 20% GRATUITY APPLIES TO ALL FOOD, DRINK AND MINI GOLF CHARGES. FOOD AND MINI GOLF CHARGES ARE ALSO SUBJECT TO AN 8% SALES TAX. DRINK CHARGES ARE SUBJECT TO CITYWIDE APPLICABLE LIQUOR TAX. ALL RENTAL FEES ARE NOT SUBJECT TO ANY ADDITIONAL TAXES.

ARE YOU ALLOWED TO BRING YOUR OWN DESSERT?

YES, ANY DESSERT PROVIDED BY THE HOST IS SUBJECT TO A \$20 CUTTING/SERVING FEE.

IS MINI GOLF 50% OFF FOR ONE OR BOTH COURSES? DOES EVERYONE HAVE TO PLAY?

THE MINI GOLF COURSE IN THE AREA THAT YOUR EVENT IS BOOKED IS 50% OFF. GUESTS ARE NOT OBLIGATED TO PLAY AND WILL NOT BE CHARGED IF THEY CHOOSE NOT TO. IF GUESTS WANT TO PLAY ON THE OTHER COURSE, THEY CAN PUT THEMSELVES ON THE WAITLIST AND IT IS \$10 PER PERSON PER ROUND.

DOES HAPPY HOUR PRICING APPLY?

NO, HAPPY HOUR PRICING DOES NOT APPLY FOR PRIVATE EVENTS. OTHERWISE STATED, GENERAL PUBLIC DISCOUNTS DO NOT APPLY TO PRIVATE EVENTS.
