Purchaser agrees to pay a 50% cancellation penalty if Purchaser cancels less than thirty (30) days prior to the event date. If event is within 10 days of booking VIP DJs may charge a premium rate on top of the regular rate of \$100-\$300 to be set based on demand of services for selected date.
